



## AUTOBAHN COUNTRY CLUB CLUB ACCESS PROCEDURES FOR MINORS

Many of our Club members have children ages 16 or 17 who are licensed drivers and who wish to come to the Club without their parents. We encourage everyone to come to the Club and enjoy the facilities whenever they can.

With our insurance carrier's help, we have developed an annual Parental Consent Waiver which allows minor children of Club members to have access to the Club without their parents being present so long as the following procedures are strictly followed:

1. Children of Club Members ages 16 or 17. Children of Club members ages 16 or 17 who are licensed drivers will be allowed access to the Club's road course and kart track without their parents being present so long as the Club has on file for each year an annual Parental Consent Waiver that is signed by both parents in the presence of the Club's registration staff. Alternatively, both parents may sign the annual Parental Consent Waiver off-site, provided the Parental Consent Waiver is notarized and delivered to Club registration in original form, unfolded and without any alterations or staples.

Once a properly completed annual Parental Consent Waiver is on file, the child of a Club member ages 16 or 17 must only complete the daily Minor Waiver in the presence of the Club's registration staff in order to gain access to the Club's road course and kart track without the child's parents being present.

If a properly completed annual Parental Consent Waiver is not on file, a child of a Club member ages 16 or 17 will be allowed access to the Club's facility (but not its road course or kart track) without the child's parents being present if a daily Minor Waiver is completed by the child in the presence of the Club's registration staff.

2. Children of Club Members under age 16. If a properly completed annual Parental Consent Waiver is on file for a Club Member's child under age 16, the child under age 16 need only complete the daily Minor Waiver in the presence of the Club's registration staff in order to gain access to the Club if the child's parents are not present. Under no circumstances will a child under age 16 have access to the Club's road course and kart track without a parent of the child being present.

3. Minor Guests. Guests accompanied by a Club member or a child of a Club member who is under age 18 must complete the daily Minor Waiver in the presence of the Club's registration staff in order to gain access to the Club. Guests ages 16 or 17 who are accompanied by a Club member or a child of a Club member and who are licensed drivers will be allowed access to the Club's road course and kart track only if both parents of the guest are present and properly complete the Parental Consent Waiver. Alternatively, the guest ages 16 or 17 will be allowed access to the Club's road course and guests who are of an age to safely navigate the kart track up through ages 16 and 17 will be allowed to access the kart track if the guest's parents sign the Parental Consent Waiver off-site, provided the Parental Consent Waiver is notarized and delivered to Club registration in original form, unfolded and without any alterations or staples.
